BCA COVID-19 BEHAVIOUR AGREEMENT WAIVER FORM

In signing this form, I realize and acknowledge that my participation at Briercrest College and Seminary and Briercrest Christian Academy in the midst of COVID-19 requires functional adjustments in order to be granted permission to have a face-to-face college, seminary and high school experience.

STUDENTS ONLY

I understand that my parent/guardian will be required to sign this form in order for me to participate at BCA this year. I agree that I will cooperate fully with the policies and protocols outlined below.

INFORMATION FOR PARENTS/GUARDIANS

In cooperation with and adhering to the requirements and recommendations of the Health Ministry of the province of Saskatchewan, Briercrest College and Seminary and Briercrest Christian Academy have formulated a workable plan for minimizing the spread of COVID-19 while students are in attendance.

To keep the risk of COVID-19 on the Briercrest Campus low, students and staff will be required to follow some stringent guidelines and practices. If a student is unable or unwilling to follow the requirements, it would be wise for this student to remain off campus for this fall. Critically, if after a student arrives, and it becomes apparent that he/she is either unwilling or unable to comply with the required practices, he/she will be asked to leave campus and complete their studies online.

Though stringent guidelines and practices will be required, there are no guarantees that the Briercrest Campus will be COVID-19 free for the entirety of the fall school term, but the College, Seminary and Academy are making every effort to follow the provincial health requirements in every attempt to minimize the risk to students, staff and faculty as they return to study.

Given the complexity of the how illnesses are presented, students and parents/guardians must be compliant if COVID-19 testing is required. Students or parents/guardians who choose to forego this should consider remaining off campus for the fall term.



REGARDING BCA STUDENTS

Dorm students awaiting test results for COVID-19: Students may be asked to isolate/quarantine off campus and will be required to access their studies online rather than in-person until the test results determine the next appropriate steps.

Day students awaiting test results for COVID-19: Students will be invited to isolate/quarantine at home with their parents and will be required to access their studies online rather than in-person until the test results determine the next appropriate steps.

In the event of a positive COVID-19 case for a dorm student, it will be the responsibility of the parent, guardian, or designated person to pick up the student within 24 hours and to take the student home or to quarantine with the student off campus*--or to follow other such direction as issued by the Saskatchewan Health Authority at that time. Students will be required to access their studies online rather than in-person until a medical professional determines a timeline for the student's return to campus.

*Only the cost of an emergency overnight accommodation for parent, guardian, or designated person (and the student) at The Pilgrim Inn will be covered by Briercrest. Further costs will be the responsibility of the parent, guardian, or designated persons.

In the event of a positive COVID-19 case for a day student, it will be the responsibility of the parent, guardian, or designated person to quarantine with the student. Students will be required to access their studies online rather than in-person until a medical professional determines a timeline for the student's return to campus.
